- Agencies having GST/TIN/SRIN/PAN number as applicable with Trade Certificate (Form 17) issued for "Body Building & repair work".

The bidders are to submit their tender in separate sealed covered envelope super scribing Cover-A (technical bid) and Cover-B (price bid) and both the sealed covers should be put in third outer cover which should be super scribed as "TENDER FOR BODY BUILDING WORK (HEARSE VAN)".
- Document pertaining to experience in handling Govt. assignment may be submitted along with proposal. (03 nos. of Order Copy)
- All the payments are to be made through Account Payee Cheque only.
