




2. The sale of the Bid document shall start from the date of publication in Newspaper during office hours in the office of the Panchayat Samiti, Korei, Jajpur
3. Bids shall be received in the office of the Panchayat Samiti, Korei, Jajpur till **Dt. 28.11.2018 up to 5.00PM-through Registered Post/Speed Post only**. The authority will not be held responsible for postal delay in the delivering of the documents or non-receipt of the same.
4. The tender will be opened in the office of the Panchayat Samiti, Korei, Jajpur at **11.00AM, on 30.11.2018** in presence of the bidders or their authorized representatives
5. The bid documents can be had from the Office of the Panchayat Samiti, Korei, Jajpur in person on application and payment of cost of bid documents in **demand draft/Bankers cheque drawn in favour of B.D.O, Korei, Jajpur payable at S.B.I. Panikoili** . The bid document can be downloaded from the official web site of Jajpur District (<http://www.jajpur.nic.in>). In case of downloaded bid document the cost of bid document should be attached with the bid. The cost of bid document is not refundable. The envelope containing bid document should be "**superscribed with Tender Call Notice Number-5135 / 17.11.2018**"
6. The undersigned reserves the right to negotiate or reject any or all the tenders in the interest of the Govt. with or without assigning any reason thereof. Any dispute in this matter will be settled up under the Jurisdiction of Jajpur District. **(The bids of the defaulting contractors of this block those who have not completed the work in time are liable for rejection.)**
7. The performance security shall be obtained from the bidder when the bid amount is less than the bid put to tender. In such an event, the bidders who have quoted less bid price/rates than the bid cost put to tender shall have to furnish the exact amount of differential cost i.e bid cost put to tender – (minus) the quoted amount as Performance Security in shape of Demand Draft/ Term Deposit receipt pledged in favour of B.D.O. Korai in the sealed envelope in absence of which the Tender will be summarily be rejected.
8. The sanctioned amount will be released in 3 installments (50%, 25% & 25%). The release of second and third installments will be processed only after receipt of 8% Utilization Certificate of previous installment. The expenditure shall be made adhering to the Govt. schedule of rates and quality work to be monitor regular by the regional office civil unit of OMC.
