



TERMS AND CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire basis.

1. The hired vehicle, during period of contract, shall have all necessary valid MV documents such as valid registration certificate, Insurance certificate and DL of the driver available all the times. The Department/Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles loss of life/injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The owner of the vehicle shall be responsible for all such litigations.
2. The hire charges to be paid on monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of engine, Gear Box and different coolant, Tyres and Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
7. In case of emergency, the driver will have to report for duty at any time of the day as per actual requirement of hirer.
8. Hire charges in a month as per actual engagement and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder will be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provider and no advance payment will be made.
9. If the services are found to be unsatisfactory, the client has the authority to disengage the vehicle at any point of time without assigning any reasons thereof.
10. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to give one month notice before such withdrawal of service and termination of agreement.
11. The vehicle shall not be more 3 years old from the date of initial registration and also in good running condition during the period of contact and having carrier to carry RWSS spare parts.
12. The application form must be signed by the vehicle owner or bidder and properly sealed and also attached with all relevant documents.
13. If the bidder violates any of the terms of contracts, the office shall forfeit the entire amount of Security deposit
