In pursuance of Letter No. 2312/R&DM (DM) dt. 01.05.2019 of State Port Engineer, Govt. of Odisha, R&DM Deptt., Rajiv Bhawan, Bhubaneswar, after observing all formalities the following qualified persons are hereby engaged as Launch Driver & Boat Khalasi for operation of power boats stationed at different blocks purely on temporary basis with consolidated remuneration of **Rs. 8,880/-** (Rupees eight thousand eight hundred eighty) & **8070/-** ( Rupees eight thousand seventy) only respectively per month for the period from dt. 01.07.2019 to 30.11.2019 for relief management during the year 2019 subject to the following term and condition.
