Sub: **Regarding Joint Grievance Hearing on every 3rd Monday of each month instead of every 1st Friday of each month at Town Hall, Jajpur Road.**

Sir,

With reference to the subject cited above, I am to say that Govt. in GA & PG Department have declared each Monday as joint grievance hearing day. Accordingly the joint grievance hearing is being held in district headquarter on the 1st Monday & the remaining Mondays of the Month is being held in different Block Head Quarters in rotation basis. Besides, grievance hearing is being held at the office of the ADM Kalinganagar on the 1st Friday of each Month.

However, it is seen that very few persons are coming to the Grievance Camp at Office of the ADM Kalinganagar, Jajpur Road on 1st Friday of each Month. One of the reason for such attendance that in the same week another grievance hearing is being held by all district level officers in some or other Blocks.

In view of the above facts, it is decided that like the joint grievance hearing at DHQ, Jajpur grievance hearing will be held on every 3rd Monday of each month instead of 1st Friday at Town Hall, Kalinganagar area, Jajpur Road. In this regard you are requested to make necessary arrangement with Executive Officer, Vyasaganar Municipality for smooth conduct of joint grievance hearing at Town Hall, Jajpur Road & to generate awareness of the changed structure of grievance hearing may please be made among public to avail the same.



Sub: **Regarding absence of officers during joint grievance hearings thereof.**

Madam/Sir,

In inviting a reference to the captioned subject, I am to say that a series of instructions have already been issued earlier to remain present during Joint Grievance Hearings, Samadhan Sibira, Maha Samadhan Sibira & Krushi Samadhan Sibira, but officers are found absent during the joint grievance hearing.

You are aware that the Govt. in GA & PA Deptt. have declared Monday as meeting free day & no other meeting shall be programmed on Monday. Hence, there is no question of remaining absent during joint grievance hearings. Besides some officers are sending their representatives to the above noted camps which is not acceptable. If the District Collector and Superintendent of Police have time & are remaining present in all grievance camps then remaining absent or sending representatives to the grievance camps without sufficient and valid reason is simply unacceptable. Also some officers are in the habit of reaching the grievance camps much after the stipulated time as per their sweetwill. This practice should be stopped immediately.
