**Terms and Conditions :**

- Cost of Tender Paper :** The tender specifications can be obtained from Panchayat Samiti Office, Barchana on payment towards cost of the tender papers as mentioned above (Non-refundable ) in shape of Bank Draft in favour of Block Development Officer, Barchana in S.B.I. Bank having its branch at Chandikhole.
- Sale of Tender Papers :** The tender documents will be sold from 15.11.19 to 29.11.19 at Panchayat Samiti Office Barchana. The tender documents will be sold during the above mentioned period between 10 AM to 5 PM on working days only. The cost of bid document should be attached with the bid (in shape of Bank Draft payable at SBI, Chandikhole).
- Date of receipt and mode of submission of Tender Papers :** The tenderers have to submit sealed tender papers in complete shape through Registered Post /Speed Post Only to the B.D.O., Barchana in his official postal address. The last date of receipt of tender papers is 29.11.19 (up to 5PM)). The undersigned will not be responsible for postal delay if any or non-receipt of the papers in time. The tenderers must super scribe the name of the work/project on the sealed envelopes.
- Date of Opening of Tender Paper:** The tender papers shall be opened on 30.11.19 at 11 am at Conference Hall, Barchana Block in the presence of the tenderers or their authorized representatives having written authorization for the purpose and the tender committee.
- Earnest money deposit:** The E.M.D. is to be deposited in shape of Post Office Short term deposit/Term deposit/N.S.C./KVP, or deposit receipt of any nationalized bank duly pledged in favour of Block Development Officer, Barchana. The Tender Papers without required amount of E.M.D. will not be considered and transfer or adjustment of E.M.D. is not also admissible.
- Document to be attached :** The tender is to submit in one cover is to contain E.M.D., signed DTCN, Price bid duly filled in and signed by the tenderer along with the following documents should be furnished with the tender papers failing which the tender will be liable to rejection.
  - E.M.D. pledged in favour of the Block Development Officer, Barchana.
  - Attested copy of Contractor Registration Certificate
  - Attested copy of PAN card.
  - Up to date GST clearance certificate.
  - Attested copy of up to date valid labour license.
  - Attested copy of Caste Certificate issued by competent authorities in case of S.C. /S.T. contractors desirous of availing preference.
  - Affidavit as regards the fact of availing award of work without submission of E.M.D. /I.S.D. during the current financial year in case of Engineer Contractors desirous of availing exemption of E.M.D.
  - Affidavit about the authentication of document including bank guarantee.
- Additional Performance Security Deposit:** The additional performance security shall be deposited by the bidder, when the bid amount less than the estimated cost put to tender. In such case/event the bidder who have quoted less bid price than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security in shape of Post office short term deposit /NSC/K.V.P/ deposit receipt of any Nationalized bank duly pledged in favour of Block Development Officer, Barchana in the sealed envelope along with the price bid at the time of submission of bids.
- Forfeiture:**
  - The E.M.D. amount will be forfeited, if the tenderer backs out from the offer of acceptance of tender, by the competent authority.
  - Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.
  - On review of the last performance of the works executed through B.D.O., Barchana previously, the lowest- 1 tenderer may/may not be considered for the works, though he/she becomes lowest -1 tenderer.
  - The Contractors who have failed to execute projects of this agency/backed out from execution process/abandoned the project work midway/those who have been declared by this agency to be the defaulters otherwise will not be allowed to participate in the present tender process. If any of such contractors participates then his/her papers will not be considered at all.
  - The undersigned reserves the right either to reject any or all tenders or cancel the entire process without assigning the reason thereof.
