1. Incomplete and conditional tenders shall be summarily rejected.
2. The quoted rate should be inclusive of all taxes if any.
3. Rates are to be quoted in words and figures without any cutting/overwriting
4. The rate quoted shall remain valid for one year from the date of finalization of the tender.
5. The agency should quote the rates after visiting the site and proper assessment of work.
6. Technical Bids and Financial Bid should be signed by the same authorized signatory.
7. Any increase in rate will not be entertained during the valid period.
8. The authority reserves the right to accept rate quoted or not.
9. True Xerox copy of GST certificate, PAN No. with self attested must be produced with the quotation. If called for original document shall be produced for verification.
10. EMD Rs.5,000/- (Rupees Five thousand only) only in shape of demand draft in favour of Zilla Swasthya Samiti, Jajpur should be enclosed with technical bid, which will be refunded to unsuccessful bidders in due course. No other mode of payment shall be accepted and will not be considered. Request for exemption of EMD by firm and adjustment for any previous deposit will not be entertained. The EMD of successful bidder will be refunded without interest after completion of the work.
11. The authority reserves the right to cancel part or whole of tender without assigning any reasons thereof.
12. The sample design and brand of materials must be accompanied with technical bid in shape of brochure. The Completion time would be 30 days. In case of delay, as Liquidated Damage clause, a penalty of 1% per week should be deducted.
13. The measurement shall be done jointly by the bidder and JE (Civil).
14. All transportation, packing/forwarding, freight, installation & labour cost etc. shall be arranged by the successful bidder.
