Quotations are here by invited from the interested light vehicle owner to provide two nos of vehicle on hire basis for official use in the RMC Jajpur as per following specifications, terms and conditions.

SPECIFICATION

- i. The vehicle should be a Bolero or equivalent type.
- ii. Non –Air condition diesel vehicle in good running condition.
- iii. Period of contract is from **01.01.2020 to 30.04.2020**
- iv. The vehicle will be used for 24 x7 (Hours) service in a month.
- v. All types of repair/maintenance are to be borne by the vehicle owner at his own cost including payment of tax ,wages of driver etc.
- vi. The vehicle owner should have valid license and permit etc.
- vii. The owner is responsible for engagement of one dedicated driver to perform the Govt. duty without any hesitation.
- viii. The owner should submit a certificate from MVI concerned about fuel consumption with the quotation.
- ix. Fuel and Lubricants will be supplied by this office.
- x. Log Book and stock issue register of fuel etc. are to be maintained according to Govt. procedure and signed by the driver and the officer using the vehicle.
- xi. The quotations in sealed cover will be received from **23.12.2019 to 31.12.2019** except Sundays & holidays by Secretary RMC from 11am to 4pm. The said quotations will be opened on **31.12.2019 on 4.30 p.m.** in the chamber of Additional District Magistrate ,Jajpur cum Chairman RMC ,Jajpur
- xii. The concerned Vehicle owner should execute an agreement containing all the term and conditions in Indian non judicial stamped paper with the under signed with 3 days on receipt of engagement order.
- xiii. The driver engaged by the vehicle owner should have valid driving license.
- xiv. The period of engagement may be extended if required .
- xv. The hiring charges of vehicle per month don't exceed Rs 20000/ per month and mileage in K.Ms. not less than 10K.Ms./per liter.
- xvi. The vehicle owner should have to arrange alternative vehicle in case of breakdown of the engaged vehicle.
