

2. The EMD shall be forfeited if the bidder withdraws his bid during the period of bid validity.
3. The EMD of successful bidder shall be retained towards making of the security for the performance of the contract period and the EMD of unsuccessful bidders will be returned after completion of bidding process on application.
4. No bidder will be permitted to furnish the quotation in their own manuscript papers. No letter should accompany the quotation.
5. In case of any dispute the decision of the Municipality is final and binding on the firm.
