

Sealed quotations in plain paper are invited by the undersigned for disposal of the following vehicle of DRDA, Jajpur. The intending quotationer may inspect the vehicles during the working hours of any working day at DRDA premises. The sealed quotation should be accompanied with earnest money of Rs.5000/- (Rupees Five Thousand) only in shape of Bank Draft to be drawn in favour of Project Director, DRDA, Jajpur, Payable at SBI, Jajpur Town Branch, which would be refunded to unsuccessful quotationers after finalization of the quotation process. The sealed quotation should reach to the office of the Project Director, District Rural Development Agency(DRDA), Jajpur by **1.00 P.M. of dt.04.12.2020** through Regd. Post/ Speed Post and shall be opened on same day i.e. **04.12.2020 at 3.30 P.M.** in presence of quotationers or their authorized representative in the office of the Project Director, DRDA, Jajpur. The envelope is to be superscripted with "**Quotation for disposal of Vehicle(Mahindra Jeep) Regd.No. OR04A- 0614**". The successful quotation shall have to deposit 50% of the quoted amount immediately after the quotation is opened and accepted by the competent authority on the same day. The balance 50% amount shall have to be deposited within 7 days. The delivery of the vehicle will be made only after depositing full quoted amount failing which the earlier deposited including EMD will be forfeited.

On failure to remove the vehicle within the stipulated period of 7 days the ground rent @2% of the bid money shall be charged for each day or part of the day till removal of the vehicle from the site. The authority reserves the right to reject any or all of quotations without assigning any reasons thereof. 


