QUOTATION CALL NOTICE

Quotations are here by invited from the interested light vehicle owner to provide two nos. of vehicle on hire basis for official use in the RMC Jajpur as per following specifications, terms and conditions.

SPECIFICATION

- i. The vehicle should be a Bolero or equivalent type.
- ii. Non –Air condition diesel vehicle in good running condition. The vehicle should not be older than three years.
- iii. Period of contract is from 01.01.2021 to 31.05.2021
- iv. The vehicle will be used for 24 x 7(Hours) service in a month.
- v. Apart from the working days the vehicle can be used on holidays/Sundays and even in odd hours I,e. in night time in case of emergency.
- vi. All types of repair/maintenance are to be borne by the vehicle owner at his own cost including payment of tax ,wages of driver etc.
- vii. The vehicle owner should have valid license and permit etc.
- viii. The owner is responsible for engagement of one dedicated driver to perform the Govt. duty without any hesitation.
- ix. The owner should submit a certificate from MVI concerned about fuel consumption with the quotation.
- x. Fuel and Lubricants will be supplied by this office through Token.
- xi. Log Book and stock issue register of fuel etc. are to be maintained according to Govt. procedure and signed by the driver and the officer using the vehicle.
- xii. The quotations in sealed cover will be received from 15.12.2020 to 23.12.2020 except Sundays & Holidays by Secretary RMC from 11am to 4pm. The said quotations will be opened on 24.12.2020 at 4.00 p.m. in the chamber of Additional District Magistrate ,Jajpur cum Chairman RMC ,Jajpur
- xiii. The concerned Vehicle owner should execute an agreement containing all the term and conditions in non judicial stamped paper with the under signed with 3(Three) days of receipt of engagement order.
- xiv. The driver engaged by the vehicle owner should have valid driving license.
- xv. The period of engagement may be extended if required .
- xvi. The hiring charges of vehicle per month don't exceed Rs 31,000/-
(Rupees Thirty one thousand) only per month and mileage in K.Ms. don't less than 10K.Ms/per liter.



- xvii. The vehicle owner should have to arrange alternative vehicle in case of break down of the engaged vehicle.
