The Executive Officer, Vyasaganar Municipality, Jajpur Road invites sealed Quotations from persons/firms sufficient knowledge, manpower, machineries and experience in running integrated mosquito and pest control operation in Urban Local Bodies/township areas and having valid license to stock and use restricted insecticides for commercial pest,. control operations issued by the competent authority according to the insecticide Act 1968 and rules there under, for the below mentioned works. The quotation should accompany self-attested photo copies of PAN Cards/GST/TCC /EPF &ESI registration certificate/proof of work experience & work completion certificate/Valid paste control license. The EMD of Rs.20,000 and the cost of bid document Rs.2000/- (non refundable) in shape of Bank draft of any scheduled Bank drawn at Jajpur Road branch favouring the Executive Officer, Vyasaganar Municipality must be attached with the bid documents. The quotation should also accompany an undertaking to the effect that the bidders/firms shall produce the required Labour License and insurance to the cover accidental risk of all categories of work men under the work men compensation Act, if awarded with the work. The bidder /firm shall require to submit a certificate duly signed by a reputed expert not below the rank of ADMO, PH of the State Govt to the effect that the chemicals he./they proposed to use in the mosquito control operation are genuine, effective and result oriented. The quotations complete in all respect should be delivered reach to the undersigned latest by 5P.M of dtd. 16.01.2021 through speed post/ Registered post/Courier service only which will be opened on dtd.18.01.2021 at 11.00 A.M in presence of the bidders or their authorized representatives if any. In absence of both the undersigned can open the same without notification. The rate including cost & conveyance of all materials, chemicals, diesel,solutions, machineries & equipments, vehicles and fuel required to carry out the operation, tools and tackles with taxes, cost of all labor etc should be quoted both in figures and words and in case of discrepancy between the two the rates as indicated in words will be considered. The selected bidder will have to execute an agreement containing the detailed scope of work, terms & conditions and mode of operation & payment with the undersigned before issue of work order.
