

QUOTATION/ TENDER CALL NOTICE

Sealed quotation/tenders are hereby invited from interested service providers (Travel agencies/Tour Operators/ Private individuals) for providing 1 (one) numbers of non AC Diesel driven **vehicles** (TUV 300/ Bolero/ Sumo Gold/ Ertiga) for 9 nos of Blocks i.e, Jajpur, Dasarathapur, Korei, Rasulpur, Danagadi, Badachan, Dharmasala, Bari & Sukinda having sitting capacity not more than 5 for all need based equipment, medicines , chemicals & biological etc including driver, which shall conform to the terms and conditions (Annexure-I & II).

1. The vehicle must be in Road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration certificate, Insurance certificate, Fitness certificate, valid contract carriage permit, proof of up to date tax payment etc & preferably white or grey in colour. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- only shall be deposited by the intending bidders in shape of Account payee Bank Draft drawn in favour of the CDVO, Jajpur and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The monthly rate of hire charge be quoted separately in the general bid information (excluding fuel and lubricants)
6. The vehicle must have a fuel efficiency of 10 Kms per litre.
7. The details of the make and year of manufacture of the vehicle registration No., mileage (Kms covered per litre) and name of the Driver with Driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation/tender
8. The quotation completed in all respect should reach the office of undersigned on or before 23.09.2021 by **4.00 PM** in the O/O CDVO, Jajpur & also open in O/O CDVO, Jajpur conference hall on 24.09.2021 at 11AM in presence of the bidders or their authorized representatives.
9. The application form of quotation/ tender containing General Bid information & Terms & conditions for hiring of vehicles etc. will be available in SO Section of O/O CDVO, Jajpur on payment of Rs. 100 (Rupees one hundred) only from 09.09.2021 to 23.09.2021 or can be down loaded from District website. In case the application form is downloaded from jajpur.nic.in, the applicant shall furnish a demand Draft for an amount of Rs.100 (Rupees one hundred) only towards the cost of application along with the application.
