Sealed tenders in plain paper are invited for auction sale of "JEEP" from MAHINDRA Motors bearing registration No OR.04-G-2366. The interested persons / firms may quote their quotations and drop the quotation paper in the drop box placed at Tahasil Office, Bari from 11AM on 21.10.2021 to 3PM on 30.10.2021 except on Government holidays. The tender paper should be properly sealed and super scribed, "Sale of Jeep bearing No OR.04-G-2366" on envelopes addressed to the Tahasildar, Bari. The Tender Paper will be opened on 30.10.2021 at 4.30PM in the office chamber of "Tahasildar, Bari" in presence of quotationers or their representatives. If the office happens to be closed due to subsequent declaration as holidays by Government or local authority on the date of receipt / opening as specified above, the tenders will be received / opened on the next working day at the same specified time and venue. A sum of Rs.1,000.00 (Rupees One thousand) only is required to deposit as EMD in shape of cash with the Nazir of this Tahasil. The EMD of the unsuccessful bidder will be refunded through banking process after submission of their bank account within next 3(three) days.

If person / firm concerned or their representatives are found absent at that time of opening of tender papers for any cause, the bid may not be taken up for consideration. The undersigned is not liable for any delay / damage during the process or any kind of delay in receiving the quotations by Nazir of this office (by Post / hand) is not acceptable. The intending persons can inspect the vehicle in any working day after obtaining permission from Tahasildar, Bari. **The upset price is fixed to Rs.36,750/- (Rupees thirty six thousand seven hundred fifty) only.** Tender offering the highest auction price will be required to deposit the bid money on the same day failing which the EMD amounts so deposited shall be forfeited and the vehicle shall be put to either next tender or fresh auction as per the decision of the Tahasildar, Bari. The tenderer shall remove the vehicle within 7 days after making full payment. In case the vehicle is not removed from Office within the time limit, ground rented 1% of the tender money shall be charged for each day till removal of the vehicle. The ground rent so charged exceeds the price so deposited the tenders shall cease to have any claim on the vehicle.

**The applicant must be enclosed his self attested Adhar Card, Adhar based Contact Number , Self attested Bank Pass Book Photo copy and original Money Receipt must be enclosed with the application.**


