The cost of EOI documents is compulsory and the bank draft should be enclosed in original along with the EOI documents. The cost paid for EOI documents is non-refundable.



Backyard Poultry farming has been age old practice in our State. This sector plays an important role in socio-economic development of rural households. There are also farmers, who exclusively rear birds, with a flock size of 10 to 15 birds, who rarely adopt modern practices for better production. Due to want of working capital, these farmers are not able to maintain their birds with optimal management practice for which the productivity is below their potential. Therefore, 476 number of (25+25) poultry units will be established through WSHG members with hand holding support to adopt better management practices to obtain optimum production.

Objective of the Scheme:

- To provide employment generation and economic upliftment of rural household.
- To meet the demand of meat & egg by increasing the poultry population of the state.
- To support the nutritional requirement of the people through consumption of animal protein in the form of egg & meat.
- To promote poultry farming as a profitable enterprise

REQUIREMENTS

1. The weight of 28 days old chick must not be less than 250 gm.
2. The supplier needs deliver at different delivery point in co-ordination with CDVO, Jajpur District.
3. The supplier will bear all transportation cost upto delivery point.
4. The supplier will keep all chicks for 28 days in chick rearing unit & count all vaccinations point to supply.
5. The supplier will produce disease free certificate from a registered vety, practitioner.

1. The weight of 28 days old chick must not be less than 250 gm
2. The supplier needs deliver at different delivery point in co-ordination with CDVO, Jajpur District.
3. The supplier will bear all transportation cost upto delivery point
4. The supplier will keep all chicks for 28 days in chick rearing unit & count all vaccination point to supply
5. The supplier will produce disease free certificate from a registered vety, practitioner.

6. In quarantine center, the BVO/Farm Manager of the concerned Block/Farm should be in charge of all technical activities. He will make a vigilance team of Veterinary Doctor and support staff to keep a close watch on health of the animals. The team will take prompt action to treat the animals in case of any sickness and provide all technical assistance required by supplier.
7. The supplier should allow to vaccinate all birds against Rd, under and he should provide authentic documents of vaccination certified by registered veterinary doctor. Deworming of animals will also be done during rearing period.
8. All the expenditure related to maintenance, deworming, vaccination and treatment of animals will be borne by supplier.
9. Any loss of animals during rearing period will be borne by supplier.
10. The supplier should procure eggs chicks from reputed farms and will supply in phased manner.
11. After rearing period, the WSHG members will be allowed to select the chicks.
12. Costing should be done on live body weight basis.
13. The supplier should replace the under weight chicks new stocks on regular basis.
14. More number of qualified suppliers can be selected through EOI for timely supply of chicks.
15. The CDVO should take utmost care to supply the chicks to WSHG member as soon as rearing period is over.
16. Payment to the supplier will be made directly by CDVO, Jajpur after receiving the chicks by the SHG members.
17. The concerned VAS/AVAS will issue health certificate at the time of delivery.
18. Any loss of chicks during rearing period will be borne by supplier.

Other Requirements:-

- 1) Proof against experience in production/sale / supply of animals should be submitted
- 2) The bidder will quote Financial bid for supply of the intended items in separate sealed envelopes in the proforma attached in annexure.
- 3) Any deviation from the above terms and conditions will attract a penalty as desired by EOI inviting Authority which will be realized from the pending bills / invoices of the Firm/supplier or from the performance security deposited by the Firm/supplier.
- 4) The interested bidder has to provide a "BID SECURITY DECLARATION "in lieu of bid security with stipulation that if they withdraw or modify the bids during period of validity etc., they will be suspended for the time of specified in the bid documents as per the prevailing Odisha General Financial Rules vide F.D. Notification no.8943/F Dt:18.03.2021 and corrigendum No.11858/F Dt.18.04.2021.
- 5) Performance Security @ 10,000 is to be submitted by the successful bidders as per the prevailing Odisha General Financial Rules vide F.D. Notification no.8952/F Dt.18.03.2021 in form of account payee Demand Draft drawn in favour of **CDVO----- payable at Bank ----- Branch-----, District -----** as given in Annexure -VII with validity for a period of **24 months**.
- 6) In the event of any failure / default of the successful bidder with or without any quantifiable loss to the Govt., the performance security is liable to be forfeited.
- 7) The penalties to be imposed on the bidder at any stage will be decided on the basis of the violation of number of bid conditions specifically mentioned in the EOI leading to forfeiture of performance security or leading to imposition of any such other penalty by the EOI inviting Authority.

The following is the eligibility criteria for participating in the EOI:

1. The bidder should be an organization / Agencies/ Small Animal Cooperatives/Individual Traders/FPO's/JLG's for supply of animals. Any of the above entities, if registered as medium and small enterprise under MSME Development Act, 2006 in Odisha of MSMEs as applicable.
2. The bidders should not have been blacklisted or debarred from carrying on the business or should not be under a declaration of ineligibility for corrupt and fraudulent practice issued by Central Govt./ any State Govt.
3. The eligibility criteria can be changed / altered or relaxed by a duly constituted technical committee without assigning any reason thereof.

SCOPE AND CONDITION OF THE SUPPLY

1. EOI has been prepared for short listing of suppliers for procurement of Goats through due RFP process. However the indents will be placed in favour of the successful bidder selected through bidding process as per our requirement in phased manner as per the availability of funds during the contract period. The financial capping and quantity of procurement may be changed subject to availability of funds.

TECHNICAL SPECIFICATION

1. The bidder should be able to supply Black 28 days old chicks of Banaraja/Giriraj/Kruiler/Giripriya etc.
2. The age of the Does should be 6-8 months and Buck should be 8-10 months
3. The weight of Black Bengal does (6-8 months) should not be less than 8 kg, buck (8-10 months) should not be less than 10 kg weight. Similarly, weight of Ganjam Does (female goat of 6-8 months) should not be less than 12 kg and buck (male goat of 8-10 months) should not be less than 15 kg.

INSTRUCTIONS TO THE BIDDERS

The intending bidders are requested to carefully study the instruction contained hereunder before submission of their applications.

1. A bidder shall submit a single application only.
2. The application must be submitted in a prescribed format only accompanied by required documents
3. All relevant documents as asked for must be given as Annexure to the application.
4. The application along with all annexure must be submitted in a single hard bound book form duly page numbered and indexed. No loose papers or spiral bound documents will be accepted.

Submission of loose papers or spiral bound documents shall lead to the rejection of the same.
