
Terms and Conditions :

3. The Quotationer should submit photocopy of the GST Registration Certificate , PAN Card and TIN No . along with the quotation .
4. The Quotationer should have the capacity to supply all the items within 7 days of receipt of the purchase order, failing which the order will be cancelled automatically.
5. Each quotationer should submit one quotation only .
6. The Quotation paper received beyond the stipulated date/time shall be liable for rejection.
7. The Quotation paper shall be opened by the Block level purchase committee on 18/04/2022 at 05 PM in presence of the quotationers or their authorized agents in the Sukinda Meeting hall.
8. Security deposit of 2% over the Bill amount will be deducted from the Bill amount, which will be released after completion of 2nd year Local Fund Audit of Accounts of this Block.
9. The Quotationer has to submit the acknowledgement in support of supply of furniture to the concerned High School with the final Bill.
