Quotation received incompleated and after schedule date and time shall be rejected. Quotation of rate is to be made for a single item at a time from the list of medicines enclosed herewith. Rate should be quoted for unit including GST & other taxes. The item is to be delivered at CDVO, Office, Jajpur. The under signed has right to reject the quotation without assigning reasons thereof.

**PRE-QUALIFICATIONS FOR TENDERING MEDICINE QUOTATION:-**

1. The participating bidder should be a reputed pharmaceutical/ pharmacy/ Dealer/ Distributor/ Retailer dealing with veterinary medicines for supply of veterinary medicines.
2. The participating bidder who has been blacklisted by state and center Govt. or any PSU is not eligible to participate in this procurement process through quotation.

### TERMS & CONDITION OF QUOTATIONS:-

1. Quotation should be typewritten without any correction or overwriting & each page of quotation paper should be numbered
2. Supply should be made at the O/O CDVO, Jajpur within 7 days after receiving supply order
3. The bidder should have valid drug license & GST registration
4. The bidder should enclose self attested copy of PAN, copy of valid drug license, GST registration certificate and GST clearance for last quarter
5. The bidder shall submit one quotation for all the item indents to supply from the list of medicines mentioned below.
6. The tax will be charged as per Govt. guideline
7. Payment shall be made after delivery of items in proper condition & specification through RTGS after submission of bills/ vouchers. The Bank details of the bidders should be mentioned on body of bill.
