

1.	2(viii), Section 3 - Terms of Reference, Page 22	<p>2(viii), Page 22, Section 3 to now be read as follows:</p> <p>"Personnel / Staff to be provided:</p> <p>The bidder will submit a list of personnel including a Project Manager who will be involved in overseeing this project during execution period from bidder's side. The bidder will also provide at least one technical personnel for installation of a machine unit & one skilled staff for operations training of women self-help group members to operate the machine with proper technical knowledge, and to help with manufacturing a completed sanitary napkin as per specifications provided in this RFP. The bidder will also deploy at least one technical personnel as part of the operations and maintenance support as and when required. The number of resources may be subject to change as per the requirement of the project. In the event of further expansion of/extension to the plan of installation of the sanitary napkin making semi-automatic machine units, the bidder will also be required to provide handholding support accordingly.</p> <p>The cost of project manager and skilled staff for operations training must be provided only for the duration of 1 year. Cost of technical personnel/s for installation must be subsumed under installation charges. Cost of technical personnel for operations and maintenance support must be provided for the entire duration of the project (5 years)."</p>
