Sealed quotations/tenders are invited from interested reputed Travel agencies /Tour Operators or Private individuals for providing 01(one) no. of AC Diesel driven vehicles Mahindra Max/Bolero/Tata sumo) having sitting capacity not more than ten including driver, which shall confirm to the Terms and Conditions (Annexure-II) for official use by the Office of the CSO-cum-District Manager, OSCSC Ltd., Jajpur on monthly rent basis.

1. The vehicle must be in road worthy condition shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Contract carriage Permit, Proof of up to date tax payment etc which are mandatory for plying of vehicle.

2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport vehicle.

3. The Driver should be well behaved gentle and obedient in nature.

4. A sum of Rs.5000.00 (Rupees Five Thousand) only shall be deposited by the intending bidders in shape of Account payee Bank draft drawn in favour of the District Manager OSCSC Ltd., Jajpur and submit along with the tender as Security Deposit. After completion of tender process, the amount will be refunded to the unsuccessful bidders.

5. The monthly rate of hire charges shall be quoted separately in the general bid information(excluding fuel & lubricants).

6. The vehicle must achieve a minimum fuel efficiency of 10(Ten) Kms per Litre.

Annexure-II

TERMS AND CONDITIONS FOR HIRING OF VEHICLE

The following terms and conditions must be fulfilled by the successful bidders for providing a vehicle on hire on monthly rent basis.

1. The hired vehicle during period of contract shall have all necessary valid Motor Vehicle documents such as:- Valid Registration certificate, insurance Certificate, Fitness Certificate, Valid Contract Permit, Proof of Up To date Tax payment etc and Driving License of the driver available all the times. The Office of CSO-cum-District Manager, OSCSC Ltd., Jajpur hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life/injury made to any person or damage to any property on account of use of hired vehicle in any manner whatsoever. The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel and lubricants. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil of engine, gear box and different coolant, tyres & tubes, battery etc will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
4. In case of breakdown for reasons whatsoever the replacement or a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicle shall report for duty for minimum of 25 days in a month.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges of selected bidder will be paid in every succeeding month, as far as possible within 15 days of the submission of bills by the agency and no advance payment will be made to this effect.
9. The vehicle shall not be more than 03 years old from the initial date of registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, the CSO-cum-District Manager, OSCSC Ltd., Jajpur shall forfeit the entire amount of security deposit.
