4. The Tender Papers shall be opened by the Block level committee on **11/10/2022** at **11:00 AM** in presence of Tenderers or their authorized representatives.

9. The highest Tenderer shall be deposited the entire amount of the materials before lifting of the materials from the Block Office premises within 3 days from the date of final of the Tender.






