OFFICE ORDER

A stock of **Q. 21923.73** of rice kept as Flood Reserve at the FPS dealers point of the different Blocks in this District to meet Emergent Relief in ensuing flood/cyclone for the year 2022 is hereby ordered to utilise through PDS under Normal NFSA & SFSS & PMGKAY-VII during the distribution month of December-2022 as the natural calamities as over.

The FPS wise lifting plan of Rice for monthly allotment of Normal NFSA, SFSS & PMGKAY-VII for the month of December-2022 is required to prepare after deduction of flood reserve stock with FPS dealers by the M.I.I.S of the concerned Block before lifting of stocks and submit the lifting plan at the concerned RRC-cum-DSC for release of stock and intimate to the FPS retailers accordingly.

The Marketing Inspectors/Inspector of Supplies are instructed to deposit the DD after collection from the FPS dealers as per the lifting plan for lifting/delivery of rice stock by the L-II Transport Contractor of the concerned Blocks by 31.12.2022 positively, for timely distribution to the beneficiaries.
