3. The Tenderer shall have to enclose Bank draft as specified in the Tender paper towards cost of Tender paper in shape of Bank Draft in favour of the Block Development Officer, Danagadi payable at SBI, Duburi Project Danagadi.
4. The Tender Paper received beyond the stipulated date, time and without the required documents shall be liable for rejection.
5. The intending Tenderers shall have to deposit 2% of the off set price as Earnest Money along with the Tender paper in shape of TDR drawn in favour of the Block Development Officer, Danagadi. No exemption certificate will be accepted.
6. The EMD will be refunded to unsuccessful Tenderers after finalization of the Tender within one month (30 days) of finalisation of Tender process.
7. The Tenderer shall have to submit the self-attestation copy of GST, PAN Card and I'D proof of the tenderer with the Tender paper.
8. The Tenderer should be written the Rate clearly in words and figures in the Tender paper.


