No. 01 to 04 on the envelope address to the Secretary, Regulated Market Committee, Jajpur, At- Kianalikul, PO/Dist-Jajpur, PIN-755001 on or before dt. 04.03.2023 up to 5.00 P.M. and same will be opened on dt. 06.03.2023 at 11.30 A.M. in the Office of the R.M.C., Jajpur in presence of the quotationers or their authorized representatives.

- Accessories and parts should be available with the supplier to be purchased at any times at the time of requirement.
- It is for the information that each product is separate from others.
- One may apply for more than one. But paper cost will be multiple of Rs. 2,000/- (Rupees two thousand) only & same to be applied in case of EMD.
- The quotationers should bring the sample with them at the time of opening of quotations for demonstration purpose.
- The undersigned shall not be held responsible for any postal delay. The approved quotationer shall deliver the equipments within 7(Seven) days from the date of placement of order positively.






