
NOTICE

In pursuance to letter no. 12672/PR, Date-13/7/17 , GST rules and as per Odisha Panchayat Samiti Accounting Procedure Rule no. 72 , this office is here by decides to follow below points scrupulously.

1. This Panchayat Samiti is going to maintain a list of registered contractors, who will be eligible for submitting tenders to the Panchayat Samiti for any work to be executed, by the Panchayat Samiti henceforth.
2. Any person desire of registering himself /herself as a Panchavat Samiti contractor, s/he should apply to the Block Development Officer ,Danagadi in writing, stating his qualification and previous experience along with a **certificate of solvency** from a competent Revenue Officer for not less than rupees **one lakh**.
3. The Block Development Officer, after making enquiries will place such application before the Panchayat Samiti for obtaining approval of the Samiti to enlist the applicant as a contractor. The order of the Samiti on such application will be communicated to the applicant.
4. The applicant having a diploma of degree in Civil Engineering need not to produce a certificate of solvency
5. The Panchayat Samiti may delete any one's name from the list of contractors if the work of the contractor is found to be unsatisfactory and such fact shall be communicated to the person concerned.
6. The applicant must have valid GSTIN number.
7. In future tenders the listed contractors registered under PS may be considered on priority basis.

Hence , as per above criteria, applications are here by invited from the desired contractors along with below tabular format, Xerox copy of Licence, GSTIN & a **cancelled cheque** who are seeking themselves to be empanelled for future tender works/composite supply of service.
