


- The quotationers shall enclose the attested copy of the following documents along with the quotation paper. They shall produce original certificates for verification at the time of finalization of quotation.

 - GSTIN registration certificate.
 - Copy of the PAN card (Xerox), Aadhaar Card Xerox.
 - Sample of Flex banner to ascertain the quality.
 - Experience in printing and supplying materials to Govt. offices.
 - The sealed quotations should reach the Office of the RMC, Jaipur on or before 28.12.2023 By 5 .00 P.M. through Registered Post / Speed Post.
- The quotation paper will be opened by the Purchase Committee on 29.12.2023 at 4 .00 P.M. onwards in presence of the quotationers or their authorized representatives in the Office of the RMC, Jaipur.
- Quotation received beyond the stipulated date and time and without the above required documents shall be liable for rejection.
- The successful quotationer shall supply the materials/ fixing of Hoarding within 5 days from the date of issue of supply order. If failed to supply indented materials within the specific time mentioned in the supply order without proper and valid justification, the supply order may be cancelled. 
