The quotationers / firms or their authorized representatives are directed to remain present on the scheduled date, time and venue fixed for finalization of the quotation. No excuse will be admitted regarding his/her/their absent at the time of the opening of the quotation. The sealed envelope containing the proposals should be dropped in the box kept in District Election Section, Collectorate, Jajpur with super scribed the item of quotation. Bids received after due date will not be entertained and shall liable for rejection.

The DEO & Collector, Jajpur reserves the right to accept or reject any or all the tenders without assigning any reason thereof and also issue Corrigendum / addendum to the quotation Call Notice, which will be published in the District Website / Election Section Notice Board, if felt necessary. - 1) The interested supplier/ firms should submit quotations in a sealed envelope. All the pages of the tender papers should be signed with seal of the firms/ agencies.
- 2) Photocopy of valid PAN CARD, GSTIN registration certificate with self attested, must be enclosed by the tenderers.
- 3) Any legal dispute arises out of this is subject to jurisdiction of Jajpur only.

- 4) The tenderers should have not been blacklisted by any Government organization, If found later on, the action shall be initiated against the firm as per the law.
- 5) The District Election Officer & Collector, Jajpur reserves the right to accept or reject any or all the quotations without assigning any reason thereof and also has the right to allot / distribute the work to L2 supplier / firm at the Lowest (L 1) rate in case of LI bidder fails to deliver items within the stipulated time and L2 supplier must be agreed on it.
