

1. The applicant has to be tender form duly filled up signed along with all requisite document in a sealed cover envelope.
2. The applicant has to deposit a non refundable amount i.e **Rs.5000(Five Thousand)** towards the cost of the bid document in shape of Bank draft of any nationalized bank in favour of **Executive Officer Vyasaganar Municipality** drawn at Jajpur Road branch.
3. The applicant has to deposit a refundable amount i.e. **Rs. 30,000/-(Thirty Thousand)** towards the cost of EMD in shape of DD of any nationalized Bank in favour of **Executive Officer, Vyasaganar Municipality payable at Jajpur Road Branch.**

5. The opening of tender documents will be held on **23.02.2024 at 11.00A.M** in the Council Hall for scrutiny & selection of highest bidder.
6. The upset price has been given in the tender call notice.
7. The quoted tender price of the highest bidder offered will be deposited one time failing which his offer will stand cancelled and EMD thereof will be forfeited. The Second highest bidder will be invited to deposit the same amount at the rate quoted by highest bidder. Further if more than one applicant have quoted same amount then the applicant will be selected by draw of lottery.
8. The authority shall not be held responsible to any type of loss or also the authority reserves the right to revoke the work order at any time without assigning any reason thereof.
9. If any dispute arising during the lease period of contract, the contract can be appealed before the Municipal authority Vyasaganar, which decision is final & binding.
