

7. The rate per sports equipment in the above list should be quoted inclusive of all taxes separately and the selected(short listed) suppliers/sellers shall be awarded the supply order. He will supply the equipment as per the requirement placed in the supply order.
8. All pages of the quotation should be duly signed by the suppliers/sellers or authorized signatory and stapled properly.


