The quotation should accompany self-attested photo copies of PAN Card / GST / MSME / EPF & ESI registration certificate / proof of work experience & work completion certificate / Valid paste control license. The EMD of Rs. 5,000 and the cost of bid document Rs.1000/- (non refundable) in shape of Bank draft of any scheduled Bank drawn at Jajpur Road branch favoring the Executive Officer, Vyasagar Municipality must be attached with the bid documents. The quotation should also accompany an undertaking to the effect that the bidders / firms shall produce the required labour License and insurance to be covered accidental risk of all categories of work men under the work men compensation Act, if awarded with the work. The quotations complete in all respect should be delivered / reach to the undersigned latest by 5 PM of dtd. 09.08.2024 through speed post / Registered post / Courier service only which will be opened on dtd. 12.08.2024 at 11 A.M at Conference Hall of Vyasagar Municipality in presence of the bidders or their authorized representatives if any. In absence of both the undersigned can open the same without notification. The selected bidder will have to execute an agreement containing the detailed scope of work, term & conditions and mode of operation & payment with the undersigned before issue of work order. Any other details can be had from the office of the undersigned during office hours on all working days.
