1. Auction notice for disposal of Obsolete/unserviceable Equipment, Instruments, Furniture and BCL and other items etc.
2. The above items are located in the premises of Health Institutions of Jajpur and details of contact person for inspection as per Annexure and tender accepting authority are as under:



3. An EMD of Rs.10,000/- (Rupees ten thousand only) should be deposited with the tender in the form of Demand Draft from any Nationalized bank in favor of "CDM & PHO, Jajpur, payable at Jajpur.

General Terms & Conditions:

1. Bidders having valid GST and PAN card are eligible to participate in tender.
2. Bidders may inspect the items on the stipulated dates & time as mentioned above.
3. The items shall be sold to the highest amount quoted bidder. The bids are invited for the lot (i.e. all the items of obsolete/ unserviceable Equipment, instruments, Furniture and BCL and other items etc. as a whole of institution wise and no bid would be accepted for any part of the same. Evaluation should be done total amount quoted.
4. List of institutions and contact numbers are given at Annexure I for inspection of the items.
5. The earnest money Deposit (EMD) of successful bidder shall be adjusted from the total payment.

6. The successful bidder has to make full balance payment, after due adjustment of the EMD, in the form of Demand draft in favor of "CDM & PHO, Jajpur, payable at Jajpur" within three days after confirmation, failing which the offer will be cancelled and the EMD shall stand forfeited. The EMD of unsuccessful bidders shall be returned within one month after the auction date, without any interest.
7. No item once disposed to the successful bidder shall be taken back by this Department on any condition whatsoever.
8. The successful bidder will be required to lift all the items including BCL items from the disposal site within 10 days after the payment of the balance amount. On failure to do so this office shall have the right to forfeit the entire amount of the bidder and dispose of the items through the alternate bidder. The successful bidder, will also be required to make their own arrangement of transport, labour etc. for lifting the disposed items with their own cost.
9. Tender document in the sealed envelope super subscribed (TENDER FOR DISPOSAL OF OBSOLETE/UNSERVICEABLE EQUIPMENT, INSTRUMENT, BCL and other items etc) should be addressed to CDM &PHO, Jajpur.
10. The Tender must be received through Registered Post/Speed post/Courier Service on or before the due date and time otherwise it is liable to be rejected. Tenders received after the due date and time due to any reason whatsoever shall not be considered.
11. The financial bid should be given in both in figures and words as per format. Any overwriting or erasing in the figures shall not be considered for acceptance of the rates offered by the tendered.
12. The CDM & PHO, Jajpur reserves the right to accept or reject any/all tenders without assigning any reason whatsoever.
13. Each page of tender document should be signed by the bidder(s).
14. Incomplete and unsigned tenders are liable to be rejected. The bid is to be submitted for the entire lot, as mentioned in Sl.No 2 of General terms and conditions.
15. Bidder must enclose self attested Xerox copy of address proof (Voter I-card/Aadhar Card/Driving License etc.) and PAN card along with the bid.
16. Bidder must enclose the photo copy of GST Registration.
17. An earnest Money Deposit (EMD) of Rs. 10,000/- (Rupees Ten thousand only) must accompany the quotation, without which the relevant bid shall be summarily rejected.
18. The authority reserves all the right to reject or accept all or any of the tender without assigning any reason thereof.
19. All legal disputes if any relating to the tender are subject to jurisdiction in the court of law situated at Jajpur, Odisha only.
