### **SHORT QUOTATION CALL NOTICE**

Quotations are here by invited from the interested light vehicle owner to provide 2(two) nos. of four wheeler (like TATA ACE/ Pick Up) vehicle on hire basis for transporting of Grading equipments & Tarpaulins to PACS & WSHGs and Mike announcement (Awareness Programme) for Paddy Procurement of Kharif Marketing Season 2024-25 use in the RMC Jajpur as per following specifications, terms and conditions.

#### **TERM & CONDITIONS:**

- i. The vehicle should be four wheeler (like TATA ACE/ Pick Up).
- ii. Non –Air condition diesel vehicle in good running condition.  
Period of contract from 26.12.2024 to 31.03.2024 till end of Paddy Procurement (KMS-2024-25).
- iii. The vehicle will be used for 24 x 7(Hours) service in a month.
- iv. Apart from the working days the vehicle can be used on holidays/Sundays and even in odd hours i.e. in night time in case of emergency.
- v. All types of repair/maintenance are to be borne by the vehicle owner at his own cost including payment of tax, wages of driver etc.

- xii. The vehicle owner should have to arrange alternative vehicle in case of break-down of the engaged vehicle.
