Quotations are hereby invited from the interested light vehicle owner to provide one Bolero/Scorpio, vehicle on hire basis for official use in the Dharmasala Tahasil Office, as per following specifications, terms and condition.

SPECIFICATION

- i. The vehicle should be a Bolero/Scorpio or equivalent type.
- ii. Air condition diesel / Petrol vehicle in good running condition.
- iii. Period of contract is from **01.05.2025 to 30.04.2026 (12 months)**
- iv. Apart from the normal working days the vehicle can be used on holidays/Sundays and even in odd hours in case of emergency situation.
- v. All types of repair/maintenance are to be done by the vehicle owner at his cost including payment of tax etc & payment of wages of the Driver.
- vi. The vehicle owner should have valid license and permit etc.
- vii. The owner is responsible for engagement of one dedicated driver to perform the Govt. duty without any hesitation.
- viii. The owners should submit a certificate from MVI concerned about fuel consumption with the quotation.

- xi. The quotations in sealed cover will be received from **09.04.2025 to 23.04.2025** except Sundays & Holidays in the Office Chamber of the Tahasildar, Dharmasala from 7 AM to 1 PM. The said quotations will be opened on **24.04.2025 at 10 AM**.
The concerned vehicle owner should execute an agreement containing above term and conditions in non judicial stamped paper with the under signed with 3 days of receipt of engagement order.
