

Terms&Conditions


1. The Sealed Tender should reach in the office of the Block Development Officer, Dasarathpur on or before **30/06/2025** by **3.00 PM through Registered / Speed Post** only.
2. The Tenderer shall have to enclosed Bank draft amounting to **Rs.5250.00 (Rupees Five Thousand Two Hundred Fifty)** only towards cost of Tender paper in shape of Bank Draft in favour of the Block Development Officer, Dasarathpur payable at Jajpur town/Dasarathpur.
3. The Tender Paper received beyond the stipulated date, time and without the required documents shall be liable for rejection.
4. The Tender Papers shall be opened by the Block level committee on **01/07/2025** at **12.00 noon** in presence of Tenderers or their authorized representatives.
5. The intending Tenderers shall have to deposit the Earnest Money for **Rs. 50,000.00 (Rupees Fifty Thousand)** only along with the Tender paper in shape of Bank Draft in favour of the Block Development Officer, Dasarathpur payable at Jajpur Town/Dasarathpur.
