NOTICE FOR SPOT AUCTION OF ORDINARY SAND UNDER JAJPUR
TAHASIL OF JAJPUR DISTRICT, ODISHA
[Under Rule 48 of OMMC Rules, 2016 & Amendments]

Whereas, an approximate quantity of **2590 Cum** of sand has been seized by the Junior Mining Officers, O/o the Deputy Director of Mines, Jajpur Circle, Jajpur in different locations as mentioned below under Jajpur Tahasil of Jajpur District, Odisha under Rule 51 of the Odisha Minor Mineral Concession Rules, 2016 & due to unauthorized extraction/storage and no claimant has come forward.

And whereas, the disposal of the said recovered River Sand to be carried out in accordance with Rule 48 of the Odisha Minor Mineral Concession Rule (OMMC) 2016 & Amendments;

Now, therefore, it is hereby notified that the said seized quantity of sand shall be disposed of through spot auction on the terms and conditions as mentioned below:

Base Price of Sand:

- **Minimum Addl. Charge:** Rs. 2471/- per Cum.
- **Royalty:** Rs.35/- per Cum.
- **DMF:** Rs. 10.50/- (i.e. 30% of Royalty) per Cum.
- **EMF:** Rs. 1.75/- (i.e. 5% of Royalty) per Cum.
- **IT (TCS):**@ 2% of Royalty + Addl Charges.

Terms and condition:

1. Bidders must reach at the venue 30 minutes prior to the auction time.
2. Interested bidders shall register on the spot and provide valid ID proof and PAN Card.

3. The auction shall be conducted on an 'as-is-where-is" basis.
4. The auction will be conducted on the Minimum Additional Charge (MAC) fixed by the Competent Authority.
5. The selected bidder shall be intimated by the Competent Authority in the same day about his/her selection and other terms and conditions of the lease.
6. All statutory dues, including Royalty, Additional Charge, DMF, EMF, etc., shall be borne by the successful bidder. IT(TCS) will be calculated on overall price.
7. After completion of the spot auction, the Highest Bidder has to deposit 10% of the total auction amount as token of confirmation. The Highest Bidder has to deposit the balance amount within a maximum period of 24 hours. In case of non-deposit of balance amount, the token amount will be forfeited.
8. In the event of default by the highest bidder, the competent authority may issue intimation to the next highest bidder to meet the highest additional charge offered by the highest bidder who shall then be required to convey his acceptance within one day.
9. The auctioned material must be lifted at the bidder's own risk and cost.
10. The intending bidder may make field visit to the location mentioned above prior to participate in spot auction.
11. The intending bidders may consult with the undersigned for any kind query regarding auction.
12. The Competent Authority reserves the right to cancel or postpone the auction without assigning any reason thereof at any stage of auction procedure.
