

PROCEEDINGS OF TENDER / QUOTATIONS FOR SUPPLY OF 2 (TWO) NOS. OF HIRED VEHICLE TO DISTRICT EXCISE OFFICE, JAJPUR FOR EXCISE ENFORCEMENT WORK IN RASULPUR/ DHARMASALA EXCISE STATION W.E.F. 01.12.2025.

Due to non-cooperation and violation of agreement with the 2nd Party (Supdt. of Excise) 2 (Two) hired vehicle No. OD04W-1333 & OD04W-2333 engaged in Rasulpur & Dharmasala Excise Station are terminated on completion of agreement with 2nd Party (Supdt. of Excise, Jajpur) i.e. w.e.f. 30.11.2025 (A.N) vide this Office Notice No.2937/Ex. Dtd.31.10.2025. Thus, to engage another two vehicle for Rasulpur & Dharmasala ES w.e.f. 01.12.2025 Quotation/Tender Call Notice is issued vide No.2959/Ex.dtd. 03.11.2025. As per the Quotation/Tender Call Notice No.2959/Ex.dtd. 03.11.2025 of Superintendent of Excise, Jajpur, sealed quotations / tender was invited from interested persons/Travel agencies, for supply of vehicle on hire to Excise Establishment, Jajpur for excise enforcement work for strengthening enforcement activities and especially to control Excise/NDPS crimes with some stipulation in Rasulpur/ Dharmasala Excise Stations fixing the last day to 17.11.2025 by 1.00 PM. The sealed tender box was opened in presence of the Superintendent of Excise, Jajpur, Dy. Supdt. of Excise, Jajpur, Section Officer, D.E.O, Jajpur, , Inspector of Excise, Dist. Mobile Squad, Jajpur I/C Inspector of Excise, Jajpur Range & five of the participants. Altogether, 9 (Nine) applications were received for the tender. The details are enclosed vide Annexure-'A'. All the applications along with the relevant documents submitted, were scrutinised by the Committee constituted vide this Office Order No.2962/Ex. Dtd.03.11.2025.


Out of above applications received, vide Sl. No.1 & 2 of Maheswar Behera, S/O – Panu Behera, At- Choramuhan, PO/ PS- Dharmasala, Dist- Japur owner of the vehicle No. OD04W1333 & OD04W2333 quoted 1st and 2nd lowest amount. But previously due to non-cooperation and violation of agreement with the 2nd Party (Supdt. of Excise) vehicle bearing Regn. No. OD04W-1333 & OD04W-2333 are already been terminated on completion of agreement with 2nd Party (Supdt. of Excise, Jajpur) i.e. **w.e.f. 30.11.2025 (A.N)** vide this Office Notice No.2937/Ex. Dtd.31.10.2025. Hence due to the above cited reason the committee decided not to engage above two vehicles bearing Regn. No. OD04W-1333 & OD04W-2333 once again for the above purpose.

Thus, on verification of documents next lowest amount offered by the applicants were found to be correct and fulfilling the all criteria & hence, the committee unanimously declared the following applicants as winner for engagement of 2 (Two) nos. of vehicle on monthly hire basic to Dist. Excise Office, Jajpur for excise enforcement work in Rasulpur/ Dharmasala Excise Stations areas.


