As per the Tender Call Notice No. 452, Dt.20.11.2025 of this office sealed Tender/Quotation was invited from interested Travel Agencies / Tour Operators / Individuals for providing 01 (One) No. of Commercial light for official use by Office of the Assistant Drugs Controller, Jajpur Circle, Jajpur, at Jajpur Road on monthly rent basis, which was published in the district website www.jajpur.odisha.gov.in as well as in 4 Nos. of News Papers from Dt.24.11.2025 to Dt.09.12.2025 (By 01.00 PM).

During the tender time period 3(Three) Nos. of Tender/Quotations were received by this office. Which are 1. M/s SHIBA SAKTI ENTERPRISES, 2.RABINDRA KUMAR SAMAL, 3. M/S DADA KRUPA CONSTRUCTION (OPC) PVT. LTD. As per the tender procedure the sealed tender/quotations were opened by the Committee Members in presence of all the participants and representatives of the bidder.

All the applications along with the relevant documents were scrutinized by the committee constituted vide this office Order No. 447/ADC/JAJ, Dt.20.11.2025.

Out of the above applications received, the application of RABINDRA KUMAR SAMAL, At-Dihudisahi, PO-Kanikapada, PS-Mangalpur, Dist-Jajpur, PIN-755011, owner of the Vehicle Regd. No. OD 34 Y 2336 quoted 2<sup>nd</sup> Lowest Bid of Rs.35600 /-(Rupees Thirty Five Thousand Six Hundred) Only per month has been selected by the committee due to fulfillment of all the criteria as per the Terms and Condition of the Tender and became the qualified successful bidder.

Although the bidder M/s SHIBA SAKTI ENTERPRISES, At/PO-Jaraka, Dist-Jajpur has quoted the lowest bid amount of Rs.33885 /- is rejected by the committee due to Non compliance of the Terms and Conditions of the tender in Technical Bid and the Age of the Vehicle is more than 2 Years and 3 Months. and the application of the other bidder M/S DADA KRUPA CONSTRUCTION (OPC) PVT. LTD. , At-Patapur, PO-Mirzapur, Dist-Jajpur is also rejected by the committee due to Non compliance of the Terms and Conditions of the tender in Technical Bid and the Age of the Vehicle is more than 2 Years and 9 Months.

Thus the committee unanimously declared the following applicant/bidder to provide 1(One) No. of vehicle for office use at Office of the Assistant Drugs Controller, Jajpur Circle, Jajpur with immediate effect.
