**INSTRUCTION TO BIDDERS
FOR
DETAILS OF THE DOCUMENTS TO BE FURNISHED WITH TENDER**

Details of document to be furnished.

1.
 - a DD towards cost of tender paper drawn in favor of **BDO KOREI** and must be submitted **offline**.
 - b Copy of GST Certificate
 - c Copy of PAN Card.
 - d Copy of Registration Certificate.
 - e Affidavit regarding correctness of information /Certificate.
 - f Affidavit regarding no relation certificate in prescribed format.
 - g Tenderer represented through power of Attorney holder should ensure that the power of Attorney is duly signed and identified through an affidavit from the Registering authority containing the photograph of both the license holder and the person to whom the power of Attorney is given failing which the tender will be considered for rejection.
2. The documents of valid successful bidders will be verified with the original before signing the agreement. The valid successful bidders have to provide the original to the concerned Authority on receipt of such letter. Which will be sent through registered post.
3. DTCN is to be uploaded by the bidder, The bidder has to only agree/disagree on the condition in the DTCN. The bidders, who disagree on the condition of DTCN, cannot participate in the bidder.
4. The bidders have to drop DD towards cost of tender paper in approved form duly pledged in favor of Block Development Officer, Korei.
5. All the Diploma/Degree Engineering contractors have to mention the no. of exemption of EMD which they have availed in a financial year in the Affidavit.
6. The Engineering contractor should produce their original license for exemption of EMD before signing the agreement.
7. Mode of Submission of Tender: Bid documents should be submitted in **Online**.
8. **All the bidders have to submit the DD/EMD in License holder name otherwise they will get rejected.**
9. **List of Documents to be submitted offline: -**
 - i) DD Towards Tender paper Cost as mentioned in DTCN.
 - ii) FD Towards EMD as Mentioned in DTCN.
 - iii) Affidavit in Original (No Photocopy) as Mentioned in DTCN.
 - iv) Acknowledgement slip of online Bid Submission.

NB: - All these items should be dropped in a sealed envelope indicating the name of agency in the tender box placed at the office of the undersigned.

The authority reserves the rights to reject the bidders if any documents found incorrect/false at any stage of bidding.

10. The Bidding will be done online and the acknowledgement slip will be printed and submitted in offline.
