

All pages of the tender paper must be signed by the applicant. As there is a provision of **Dry Food** to be rendered in IPD, every supplier should submit one copy of valid food-licenses and he/she will abide to the decision of the undersigned, if decided later on during the financial year 2025-2026, to supply Dry Food to indoor patients.

All tender papers will be opened on dt-11.02.2026 at 03.00PM and the applicants are required to attend before the body entrusted for the purpose, on the day at 12P.M. There may be a pre-bid discussion invited by the undersigned if felt necessary, to avoid any technical litigation regarding finalization of rates. The successful supplier, if fails to deposit the security money and entered in the stamp agreement within 7 days from the date of finalization of contract and issue of supply order will be invited for supply of dietary articles.






