**NOTICE FOR PUBLIC AUCTION OF SAND UNDER VYASANAGAR TAHASIL OF
JAJPUR DISTRICT, ODISHA**

[UNDER RULE 48 OF OMMC RULES, 2016 AND AMENDMENTS THEREOF]

Whereas, an approximate quantity of **3500 CuM** of sand has been seized by the Jr. Mining Officer, O/o the Deputy Director of Mines, Jajpur Circle, Jajpur near Nayahatpatna under Vyasanaagar Tahasil of Jajpur District, Odisha under Rule 51 of the Odisha Minor Mineral Concession (OMMC) Rules, 2016 and amendments thereof due to unauthorized extraction/storage and no claimant has come forward during seizure.

And whereas, the disposal of the said seized Sand to be carried out in accordance with Rule 48 of the Odisha Minor Mineral Concession (OMMC) Rules, 2016 and amendments thereof;

Now, therefore, it is hereby notified that the said seized quantity of sand shall be disposed of through public auction on the terms and conditions as mentioned below:

Base Price of Sand:

- **Minimum Addl. Charge (MAC):** Rs. 70/- per Cum
- **Royalty:** Rs. 35/- per Cum.
- **DMF:** Rs. 10.50/- (i.e. 30% of Royalty) per Cum.
- **EMF:** Rs. 1.75/- (i.e. 5% of Royalty) per Cum.
- **IT (TCS):** as applicable.

Terms and conditions:

1. Bidders must reach at the venue 1 hour prior to the registration time.
2. The registration process for participation in the auction shall commence at 10:15 AM and closes at 10:45 AM.
3. Any intending bidders failed to reach the venue by 10:15 AM, shall not be entertained later, in no any circumstances.
4. Interested bidders shall register on the spot and provide valid ID proof and PAN Card.
5. The auction shall be conducted on an 'as-is-where-is" basis.

6. The auction will be conducted on the Minimum Additional Charge (MAC) as per the gazette notification issued by the Government of Odisha.
7. The selected bidder shall be intimated by the Competent Authority on the same day about his/her selection and other terms and conditions of the lease.
8. All statutory dues, including Royalty, Additional Charge, DMF, EMF, etc., shall be borne by the successful bidder. IT(TCS) will be calculated on overall price.
9. Before participation in the auction, the bidders are to deposit 25% of the Royalty+Addl. Charge of assessed whole quantity i.e. **Rs 91,875/-** in cash or Demand Draft as token of security. The Highest Bidder has to deposit the balance amount within working hour of the same day. In case of non-deposit of balance amount, the token amount will be forfeited.
10. In the event of default by the highest bidder, the competent authority may issue intimation to the next highest bidder to meet the highest additional charge offered by the highest bidder who shall then be required to convey his acceptance within one day.
11. The auctioned material must be lifted at the bidder's own risk and cost.
12. The intending bidder may make field visit to the location mentioned above prior to participate in public auction.
13. The intending bidders may consult with the undersigned for any kind of query regarding auction prior to **09.07.2026**.
14. The Competent Authority reserves the right to cancel or postpone the auction without assigning any reason thereof at any stage of the auction procedure.
